1 Data about you that we collect

1.1 When you use an account on the this Progressive Web Application

Purpose and Legal basis of data processing

As legitimate interest Van Oord Dredging and Marine Contractors B.V. (offers a client portal for creating a user profile for this Progressive Web Application and have access the displayed information.

How long we keep your data

We keep your user data for as long as the application is used. In case of discontinuation of the application all user data will be deleted within 12 months. You can request to delete your data or your complete account at any time by contacting our privacy officer through privacy@vanoord.com.

With whom your data is shared

Outside Van Oord, the data is only visible for the developer of the application, Label A, with whom a DPA is signed. Apart from that, Van Oord doesn't share your personal data with any other party. It is only visible to the website's administrators who are tasked with managing the user accounts and database.

1.2 Data source

For the purposes presented in this Privacy Statement, Van Oord does not obtain your personal data indirectly or from publicly accessible sources.

1.3 Cookies & trackers

The only cookies used on the website are the ones necessary for the log-in process. These are stored on the user's internet browser. No other cookies are used.

Van Oord tracks the use of the website using Matomo for the sole purpose of analysing usage of the different pages and functions. This is done anonymously based on IP addresses, of which the final 2 digits are anonymized. Tracking of usage of the website cannot be linked to the individual user accounts.



2 Security of your data

We have taken measures to guarantee an adequate level of data protection against loss, unauthorized access, changes or retransmission of your data. This concerns both measures in the field of ICT security, access to buildings and files, as well as internal rules of conduct aimed at personal discipline when dealing with confidential data of individuals. In agreements with third parties that process or receive information for Van Oord, we establish requirements with regard to information security where necessary.

3 Sharing your data

Van Oord entities

Access to your data is limited by need. We may disclose and/or receive your personal data to/from other Van Oord entities when it is necessary for business or administrative reasons. Other Van Oord entities which might have access to your personal data are also committed to the terms of this Privacy Statement.

Third parties and other recipients for security or other legitimate purposes

We may also disclose your personal data to third parties and recipients, when strictly necessary:

- To comply with valid legal obligations including court orders, governmental requests, legal claims, regulatory requirements and as otherwise authorized by law;
- To protect against fraudulent, malicious, abusive, unauthorized or unlawful use of this website and/or our network;
- To protect our rights and property, or safety of our employees and visitors, according to local legislations;
- To perform audit and investigations, when solicited by auditors and regulators;
- To perform services such as provision of but not limited to:
- For IT infrastructure and services;
- For data storage, management and protection;

In the provision of these services, third party suppliers have access to your personal data only and insofar authorized by Van Oord and in accordance with written instructions and data processing agreements, when applicable.

4 Transfer of your data outside the European Economic Area ("EEA")

Van Oord does not intend to actively share your personal data with parties outside the EEA for the purposes presented in this Privacy Statement. If applicable, Van Oord makes sure to apply suitable safeguards to protect the privacy and security of your personal data to be consistent with and honour this Privacy Statement. Furthermore, Van Oord enters data processing agreements with its third party suppliers should they host, be located at or anyhow process your personal data in a third country which does not provide an adequate level of protection.



5 Your rights

You are in control of the personal data you share with us and, therefore, you have a number of rights in relation to it such as <u>accessing</u> your data, seeking <u>rectification</u>, requesting <u>erasure</u> or <u>portability</u> of your data. Additionally, you have the right to obtain <u>restriction of</u> and to <u>object to</u> the processing of your personal data. We will make reasonable efforts to respond to your request within 30 days of receiving it. If we cannot honour your request within the 30-day period, we will let you know the reason why and when we expect to be able to respond to your request.

For the sake of care in fulfilling your request and in order to establish your identity in relation to the requested information, we may request additional information.

RIGHT TO WITHDRAW CONSENT

In the cases we process your personal data based on your consent, we reinforce your right to withdraw your consent at any time by the channels and means already mentioned in this Privacy Statement.

RIGHT TO LODGE A COMPLAINT WITH A SUPERVISORY AUTHORITY

If you are not satisfied with the way we handled your requests and rights or if you believe that we have processed your personal data in violation of the applicable laws, you have the right to lodge a complaint with the national supervisory authority.
